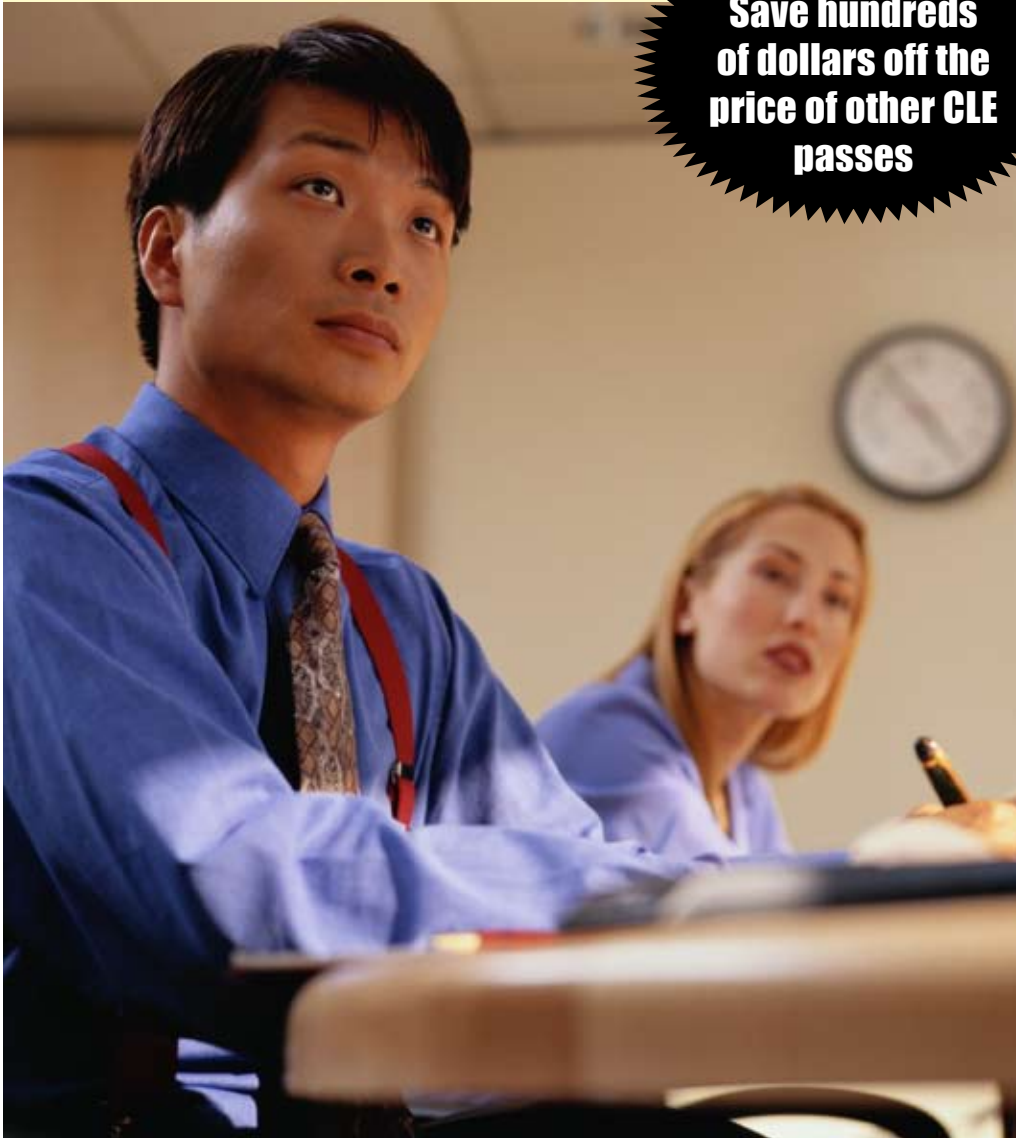

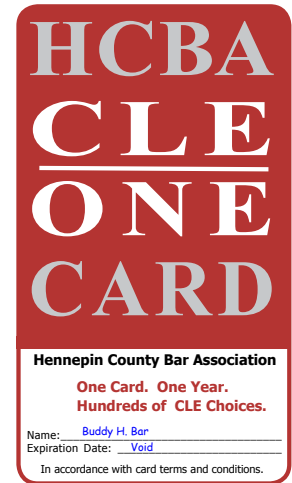

Please Read Carefully

The Hennepin County Bar Association (HCBA) CLE ONE CARD (Card) guarantees the Cardholder tuition-free admission to HCBA noon hour (1.0 credit) CLE seminars and free admission to all HCBA half-day or full-day (2.5 or more credit) CLE programs during the term of the Card.

Webcast and telephone CLE programs are not included in this offer. The Card does not provide tuition-free admission to certain small group participatory training classes, co-sponsored programs, or the Medical Malpractice Institute.

Card expires one year (12 months) after the purchase date. Under no circumstances will the term of the Card be extended beyond the 12-month period that begins on the date of purchase.

To ensure admission, registration must be received by the HCBA at least 3 days prior to the course date.

The Card cannot be used by anyone other than the individual to whom the Card is issued. Cardholders will not be admitted without their Card. Cardholder will be required to produce their Card and a photo-bearing ID card prior to admittance to any HCBA seminar.
